EIGHTEENTH AMENDATORY LETTER ORDER



TO: All Incumbent Local Exchange Carriers
All Competitive Local Exchange Carriers

SUBJECT: MODIFICATION OF THE AMOUNT OF THE MONTHLY
MAINTENANCE SURCHARGE, WHICH FUNDS THE GEORGIA
TELECOMMUNICATIONS RELAY SERVICE (TRS)

The Commission directs that the following actions be taken by the parties as indicated:

All Incumbent Local Exchange Carriers and all Competitive Local Exchange Carriers:

Increase the monthly TRS maintenance surcharge amount currently imposed (except for telephone membership corporations) on all residential and business local exchange access facilities from \$0.11 to \$0.20. This increase will be effective on January 1, 2026 or with the first billing cycle thereafter.

The above by action of the Commission in Administrative Session on December 2, 2025.

The Commission, in its Eighteenth Amendatory Letter Order concerning TRS (attached) directs all certificated Incumbent Local Exchange Carriers (except for telephone membership corporations) and all Competitive Local Exchange Carriers to amend the monthly TRS maintenance surcharge imposed on all residential and business local exchange access lines. Effective January 1, 2026, or the first billing cycle thereafter, carriers should increase the TRS surcharge from \$0.11 to \$0.20.
