(b) The <b>Regulated Provider</b> Group 1 customers - low income customers who are qualified by the State Dept. of Human Resources. Group 2 customers - high-credit risk customers who cannot obtain service from a marketer.						
(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$348.29 and is \$174.33 for qualifying senior citizens. The February 2019 base charge is \$37.97 for a typical customer with a 1.30 DDDC Factor, and is \$24.12 for qualifying seniors with a 1.30 DDDC Factor.
