(a) The prices billed to a consumer on a variable rate plan will not exceed the price the marketer has on file with the Commission in effect at the beginning of the consumer's billing cycle (meter reading cycle).						
(b) The <b>Regulated Provider</b> Group 1 customers - low income customers who are qualified by the State Dept. of Human Resources. Group 2 customers - high-credit risk customers who cannot obtain service from a marketer.						
(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$348.34 and is \$174.37 for qualifying senior citizens. The June 2019 base charge is \$25.25 for a typical customer with a 1.30 DDDC Factor, and is \$11.39 for qualifying seniors with a 1.30 DDDC Factor.

(5) Total Monthly Bill = [(Marketer rate (variable or fixed) x 16 therms) + (customer service charge) + June base charge]
