The annual base charge for a typical customer with a 1.30 DDDC Factor is \$348.34 and is \$174.37 for qualifying senior citizens. The July 2019 base charge is \$25.25 for a typical customer with a 1.30 DDDC Factor, and is \$11.39 for qualifying seniors with a 1.30 DDDC Factor.
