(b) The Regulated Provider Group 1 customers - low income customers who are qualified by the State Dept. of Human Resources. Group 2 customers - high-credit risk customers who cannot obtain service from a marketer.						
(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$365.75 and is \$191.76 for qualifying senior citizens. The March 2020 base charge is \$40.17 for a typical customer with a 1.30 DDDC Factor, and is \$26.06 for qualifying seniors with a 1.30 DDDC Factor.
