The annual base charge for a typical customer with a 1.30 DDDC Factor is \$365.37 and is \$191.37 for qualifying senior citizens. The May 2020 base charge is \$27.41 for a typical customer with a 1.30 DDDC Factor, and is \$13.55 for qualifying seniors with a 1.30 DDDC Factor.
