(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$367.77 and is \$193.77 for qualifying senior citizens. The July 2020 base charge is \$26.28 for a typical customer with a 1.30 DDDC Factor, and is \$12.42 for qualifying seniors with a 1.30 DDDC Factor.
