 (b) The **Regulated Provider** Group 1 customers - low income customers who are qualified by the State Dept. of Human Resources. Group 2 customers - high-credit risk customers who cannot obtain service from a marketer.
 (c) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$367.77 and is \$193.77 for qualifying senior citizens. The February 2021 base charge is \$46.81 for a typical customer with a 1.30 DDDC Factor, and is \$32.96 for qualifying seniors with a 1.30 DDDC Factor.

 (5) Total Monthly Bill = [(Marketer rate (variable or fixed) x 108 therms) + (customer service charge) + February base charge]
