(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$406.68 and is \$241.11 for qualifying senior citizens. The December 2021 base charge is \$40.81 for a typical customer with a 1.30 DDDC Factor, and is \$26.95 for qualifying seniors with a 1.30 DDDC Factor.
