(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$406.68 and is \$241.11 for qualifying senior citizens. The February 2022 base charge is \$47.97 for a typical customer with a 1.30 DDDC Factor, and is \$34.12 for qualifying seniors with a 1.30 DDDC Factor.
