(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$434.54 and is \$264.75 for qualifying senior citizens. The August 2022 base charge is \$29.53 for a typical customer with a 1.30 DDDC Factor, and is \$15.41 for qualifying seniors with a 1.30 DDDC Factor.
