(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$434.53 and is \$263.45 for qualifying senior citizens. The March 2023 base charge is \$47.33 for a typical customer with a 1.30 DDDC Factor, and is \$33.16 for qualifying seniors with a 1.30 DDDC Factor.
