The annual base charge for a typical customer with a 1.30 DDDC Factor is \$460.56 and is \$291.24 for qualifying senior citizens. The June 2023 base charge is \$31.26 for a typical customer with a 1.30 DDDC Factor, and is \$17.09 for qualifying seniors with a 1.30 DDDC Factor.
