The PSC Pulse vogtle unit 3 reaches 100% Energy output





In a major milestone for what has been called the largest construction project in North America, Unit 3 of the Vogtle Nuclear Power Plant expansion hit 100-percent energy output during testing.

The 100-percent milestone means the unit produced approximately 1,100 MW of electricity. Georgia Power estimates that is enough to power 500,000 homes and businesses.

Since first reaching full power, a battery of tests must be completed before the unit can start sending electricity to the grid. When the unit does begin to dispatch power, it will produce efficient, base-load energy with zero carbon emissions for an estimated 80 years.

As Unit 3 approaches completion, Unit 4 has begun receiving nuclear fuel. The uranium fuel arrived by truck in special shipping containers. Those containers are inspected and stored until the fuel is loaded into the reactor, which is expected by the end of the year.

Atlanta Magazine pointed to McDonald's 20 years of service in the General Assembly, his years of work on the Public Service Commission and his achievements in the private business sector.



GOVERNOR SIGNS LEGISLATION SUPPORTED BY PUBLIC SERVICE COMMISSION



Commissioners **Tricia Pridemore**, **Jason Shaw**, **Tim Echols** and **Fitz Johnson** were among the attendees for the Governor's signing of SB146.

PSC Commissioners supported significant legislation during the 2023 Session of the General Assembly including a new law that will increase penalties for those who would attack critical infrastructure and another that will help Georgia prepare for the expansion of electric vehicle usage.

Senate Bill 146 helps neighborhood gas stations expand into the EV charging business. The bill changes the calculation for electric vehicle charging from the current method, where consumers pay by the minute, to a new method, calculated by the kilowatt hour. The new law also creates safeguards to ensure fair competition between utility companies that offer vehicle charging and small businesses trying to get into the EV game. The language for the new law came directly from a study committee where PSC Chairman **Tricia Pridemore** served as a member.

Also passing during the legislative session, House Bill 227 increases penalties for attacks on state infrastructure, including power substations. Such attacks have been on the rise nationally with noted incidents in

North Carolina, South Carolina, Utah, Oregon, California and Wash-ington state.

While the bill was under consideration, all five PSC commissioners signed a letter of support, noting that the PSC is the Constitutional body charged with oversight of investment in critical infrastructure for the largest utilities in Georgia.

LEARNING THE INTRICACIES OF LIQUIFIED NATURAL GAS

In a joint partnership of the U.S. Department of Energy and the National Association of Regulatory Utilities Commissioners, all five PSC Commissioners and select staff from the Natural Gas Division headed to Southeast Georgia for a facility overview of the Elba Island Liquified Natural Gas Terminal.

The trip included a presentation about Atlanta Gas Light's Integrated Capacity Development Plan and how liquified Natural Gas assists in system reliability.

Also on the trip, the delegation received a tour of the Port Fuel Center at Port Wentworth with a discussion about compressed natural gas in trucking.

GOVERNOR PROCLAIMS APRIL 2023 'SAFE DIGGING MONTH'

Gov. Brian Kemp signed a proclamation declaring April 2023 as "Safe Digging Month."

The Public Service Commission inspects natural gas pipelines and is tasked with holding businesses and individuals accountable if they fail to call 811 and accidentally strike underground utilities.


said. Speakers included Ira Pearl from Cox Conserves, Wilson Mallard of Georgia Power and Ryan Sanders of

FROM HUMAN RESOURCES: STUDENT LOAN FORGIVENESS PROGRAMS



If you have student loans, you will want to read this.

We've all been hearing the ups/downs and the pros/cons of the Biden Loan Forgiveness plan. To date we still don't know the outcome and student loan payments are set to resume in September.

As a full-time state employee, you are eligible to apply for the Public Service Student Loan Forgiveness (PSLF) program – a to-

tally separate federal program specifically designed for those that work in government organizations or any employer that is taxexempt under Section 501c (3). The PSC is on the eligibility list.

Under the PSLF Program, borrowers employed in public service who make 120 monthly payments on their loans – this includes incomecontingent payments – can have the balance of their loans forgiven.

A couple of things to keep in mind:

- Your loans need to be consolidated into one loan.
- Only consolidated payments that you make on the new Direct Consolidation Loan can be counted toward the 120 payments required for PSLF.
- But, **if loans are consolidated by year end**, you may be entitled to a one time adjustment — meaning previous payments might count toward your 120 payment goal.

MILESTONES AND ACHIEVEMENTS




The PSC wishes several members of its extended family good wishes as they start college careers.


