(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$460.58 and is \$291.02 for qualifying senior citizens. The October 2023 base charge is \$36.60 for a typical customer with a 1.30 DDDC Factor, and is \$22.49 for qualifying seniors with a 1.30 DDDC Factor.
