


The clean, carbon-free energy from these two new nuclear units will power approximately 1 million homes and businesses in Georgia.

"Today is a great day and a generational event for all Georgians," said PSC Commissioner **Lauren "Bubba" McDonald**. "This plant will produce carbon-free energy for the people of Georgia for the next 80 years."

Commissioner **Tim Echols** said he is proud of the accomplishment.

"Georgia has done what no other state could do by completing the first nuclear project from scratch in more than three decades," he said. "We now have the largest clean energy site in North America."





GOV. KEMP PROMOTES SAFE DIGGING MONTH



Commissioner Lauren "Bubba" McDonald was with Gov. Brian Kemp when the Governor signed a proclamation naming April "Safe Digging Month."

Homeowners, landscapers, and professional excavators are encouraged to dial 811 or to visit Georgia 811 online at least three business days prior to digging. Professional locators are sent to the dig site. Once lines have been accurately marked, digging can safely begin.

The PSC enforces the 811 system. If utilities are damaged and the homeowner or excavator did not contact Georgia 811, the PSC Facilities Protection Division can investigate the incident and issue a significant fine. Although fines are involved, the PSC's goals are safety and prevention, not prosecution.

JASON SHAW SPEAKS TO GEORGIA CHAMBER OF COMMERCE

PSC Chairman Jason Shaw was invited to sit for a discussion session at the Georgia Chamber of Commerce Winter Board Meeting.

Over a half-hour, Shaw was interviewed by Boyd Pettit of GeorgiaLink



Public Affairs. Included in the discussion were questions about the learning curve when first elected to an energy regulatory body, the continuing construction project at plant Vogtle, and the Public Service Commission's involvement in economic development for the state.

BUSY LEGISLATIVE SESSION FOR THE PSC

In a typical session of the Georgia General Assembly, the Public Service Commission might get mentioned in a bill or two — maybe three. The 2024 session brought a flurry of activity for Georgia's energy sector.

to dial 811 or to visit HB1192, by Rep. John Carson, sets up a board to review energy usage by Georgia 811 online at data centers. The PSC appoints two members of the board.

HB300, by Rep. Trey Kelley, creates a system to decertify solar panels and sets guidelines when it is time to dispose of them.

HB1033, by Rep. Rob Leverett, creates enhanced penalties for assault on any utility worker acting within the scope of his/her duties.

can HR1498, by Rep. Trey Rhodes, sets up a study committee to determine if

privately owned water utilities should be regulated by the PSC.

HB73, by Rep. Joseph Gullett would have given the PSC oversight for companies selling residential solar panels to curb those who prey on homeowners. This bill did not pass but is likely to resurface in a future session of the General Assembly.



COMMISSIONERS ECHOLS AND SHAW ENCOURAGE GLASS RECYCLING WITH STATEWIDE CONTEST

Georgia Public Service Commission Chairman **Jason Shaw** and Vice Chairman **Tim Echols** teamed up for an Earth Day challenge, where participating Georgia students collected recyclable glass for a contest with cash prizes for their schools.

The students came through beautifully.

All participating schools received entry into Zoo Atlanta and lunch for an awards ceremony. The 10 schools that collected the most glass, by weight, received cash prizes — with Maynard Jackson High School taking top honors and receiving a check for \$2,500.

contest, having collected 4,876 pounds of glass. Each school's effort was coordinated by a student-led club. In all, more than 18-tons of glass was collected for recycling.

"Students today are pulled in many directions with competing interests," Echols said. "I want to highlight extraordinary effort for a cause that helps us all – reducing landfill waste and inspiring

environmental collaboration."

Echols came up with the idea to challenge students to a recycling contest. He approached PSC Chairman Jason Shaw with the idea and together the glass recycling contest was born.

"I can't tell you how proud I am of the work put in by these students," Shaw said. "They certainly earned the recognition – and the prizes for their schools."

COMMISSIONER PRIDEMORE TO HEAD NATIONAL GAS-ELECTRIC INITIATIVE

PSC Commissioner **Tricia Pridemore** has been named chair of a national initiative to bring together state regulators and industry leaders to find solutions that better align the gas and electric industries.

Gas Electric Alignment for Reliability, or GEAR, was established for 15 months to improve energy reliability. Julie Fedorchak, president of the National Association of Regulatory Commissioners, established GEAR and appointed Pridemore to chair. Pridemore is the 1st Vice President of NARUC and will serve as president next year.



COMMISSIONER SHAW HELPS TO EDUCATE ENERGY ATTORNEYS



State Bar Associations across the country require all practicing attorneys to complete several hours of Continuing Legal Education (CLE) each year.

To help regulatory attorneys complete their CLE hours and stay up-to-date on energy issues, attorneys with the Virginia Corporation Commission (the Virginia version of the PSC) put together an online CLE seminar with updates from utility commissioners representing several states.

Georgia PSC Chairman Jason Shaw was asked to participate as a panelist. Chairman Shaw updated participating lawyers about the Plant Vogtle expansion project, the state of natural gas in Georgia's energy mix, solar power in Georgia and the 2023 update of Georgia Power's Integrated Resource Plan.

Other Commissioners provided updates on regulatory law in Virginia, Florida, and North Carolina.

COMMISSIONER FITZ JOHNSON HELPS OPEN SOLAR-CENTRIC SHEEP BARN

Public Service Commissioner **Fitz Johnson** helped cut the ribbon at a 26,000-square-foot lambing barn in Houston County. The barn is owned and run by Silicon Ranch, one of the biggest solar farm owners in Georgia.

So why is a solar farm company breeding sheep?

Sheep raised at the new 700-acre site will help clear grass and vegetation under solar panels across the state.

Silicon Ranch hopes to have 30,000 sheep working among Georgia solar

panels by 2030. Company officials say using sheep instead of mowers and work crews saves an estimated 20-percent of overhead costs.



The sheep also get to places under the solar panels that power equipment can't and they help improve soil quality as they work.

Silicone Ranch has worked across the southeast as part of the National Sheep Improvement Program.

COMMISSIONER ECHOLS TO HEAD NATIONAL NUCLEAR WASTE SUBCOMMITTEE

The National Association of Regulatory Utility Commissioners has named Georgia PSC Commissioner **Tim Echols** to chair the Nuclear Waste Subcommittee.



The Subcommittee will bring the brightest minds in nuclear energy to three national conferences each year. Commissioner Echols says there will be a focus on small modular reactors. He has long served as Vice-Chair of the Committee and is seen as an expert in the field of nuclear energy and reprocessing. As he has since 2014, Echols is representing the United States at the World Nuclear Exhibition held in France Nov. 28 to 30.

COMMISSIONER PRIDEMORE GOES TO WASHINGTON



Commissioner **Tricia Pridemore**, along with colleagues from regulatory commissions in other states, testified before the U.S. House of Representatives during a hearing of the House Committee on Energy and Commerce. Pridemore and other Commissioners spoke about the current state of electricity production, changes in electric regulation, electric costs, and electricity reliability.

FORMER CHAIRMAN STAN WISE HONORED WITH PORTRAIT

Former Public Service Commissioner Stan Wise was honored by the PSC with the unveiling of his portrait in the Commission's hall. He is the third former PSC Chairman to be honored with a portrait. Commissioner **Fitz Johnson** and staff from the PSC Consumer Affairs Unit attended the annual meeting of the Heating Energy Assistance Team — or HEAT.

Commissioner Johnson was honored to be the keynote speaker. He discussed the many ways HEAT helps the disenfranchised in Georgia to ensure they remain warm during the winter.

HEAT began as part of Atlanta Gas Light to help combat the energy crisis of the late 1970s. After 45 years — now a separate non-profit organization — HEAT continues to help those who have a hard time keeping up with a fast-moving society in a rapidly growing state such as Georgia. With the help of concerned citizens, businesses, and public agencies in-

cluding the Georgia Public Service Commission, HEAT helps about 1,000 households each year pay their natural gas bills. Since the program began, more than a quarter million individuals have kept warm through HEAT assistance.




