The annual base charge for a typical customer with a 1.30 DDDC Factor is \$463.69 and is \$294.00 for qualifying senior citizens. The June 2024 base charge is \$33.29 for a typical customer with a 1.30 DDDC Factor, and is \$19.11 for qualifying seniors with a 1.30 DDDC Factor.
