(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$479.67 and is \$309.96 for qualifying senior citizens.						
The December 2024 base charge is \$48.89 a typical customer with a 1.30 DDDC Factor, and is \$34.72 qualifying seniors with a 1.30 DDDC Factor.
