

CHAIRMAN SHAW NAMED ONE OF GEORGIA'S 100 MOST INFLUENTIAL



PSC Chairman Jason Shaw was named one of the 100 Most Influential Georgians in 2025 by Georgia Trend Magazine.

The magazine's annual list incudes dignitaries in government, business and civic organizations. As the editors point out, the Georgians named in the issue make a positive impact whether through education, job creation, policy or hands-on healthcare services. Some perform their duties in the public eye; some work behind the scenes.

In Chairman Shaw's section, the magazine noted that PSC Commissioners ensured new businesses, including data centers, had access to sufficient energy produced by Georgia Power.

The magazine also noted Chairman Shaw's previous eight years in the General Assembly.

PRESIDENT CARTER FUNERAL PROCESSION STOPS AT GEORGIA STATE CAPITOL



President Carter's hearse stopped in front of the Georgia State Capitol on its way to the Carter Center, where he lay in repose.

PSC Commissioner Lauren "Bubba" McDonald came to the Capitol Building on a sunny but cool January afternoon to offer farewell to former U.S. President Jimmy Carter.

In 1971, Carter was sworn in as Governor of Georgia. That same year, McDonald was sworn in as a freshman

member of the Georgia State House of Representatives. McDonald said he has been honored in his many years of public service to have three presidents call him "Bubba," his nickname: Presidents Carter, Clinton

and Trump.

Carter's funeral procession made a stop in front of the state capitol where Gov. Brian Kemp and three previous Georgia Governors (Roy Barnes, Sonny Purdue and Nathan Deal) greeted the Carter family.

Commissioner McDonald and several dozen assorted dignitaries were likewise on hand to pay their respects to the beloved Georgian.

GEORGIA POWER OPENS NEW BATTERY FACILITY

Georgia Power's first "grid-connected" battery energy storage system (BESS) has opened in Shiloh, Ga., northeast of Columbus. The Mossy Branch battery facility is capable of 65 megawatts of battery storage that can be deployed back to the grid over a four-hour period, adding resiliency to the state's power grid and helping ensure reliable energy for a growing Georgia.

The Georgia Public Service Commission approved the facility as part of Georgia Power's 2019 Integrated Resource Plan. It is a standalone storage unit that connects with and charges directly from the electric grid. BESS projects like Mossy Branch support the overall reliability and resilience of the electric system, while also enhancing the value of intermittent renewable generation resources such as solar.

When the sun isn't shining, or the clouds are blocking its rays, solar panels cannot provide energy to the power grid. Battery systems can help store solar energy for use during peak times or off hours, helping to create a cleaner and more flexible grid.

UTILITIES UPDATE COMMISSIONERS ON HURRICANE DAMAGE


The Georgia Public Service Commission held a livestream Zoom call with utility officials across the state in the days following Hurricane Helene for an update on service outages and repairs.

Officials providing updates included Georgia Power, Atlanta Gas Light, electric membership corporations (EMCs), the Municipal Electric Authority of Georgia (MEAG), the Municipal Gas Authority of Georgia (MGAG), as well as telecommunications providers. Members of the public and the media were able to watch the update live via the PSC YouTube page.

Members of the public were also provided the opportunity to email questions to the Commissioners in advance of the meeting.

The Commissioners also took the time following the hurricane to remind the public about the vital work performed by Georgia's linemen and linewomen.

In a statement, the Commissioners said: "As always, when you flip the switch and the lights come on, you can thank a lineman. When the storms are over and your power is restored – quickly, correctly and safely – you can thank a lineman."

GEORGIA GENERAL ASSEMBLY 2025 SESSION BEGINS

The latest session of the Georgia General Assembly has begun and Georgia's energy usage seems to be on everyone's mind.

In the Georgia House of Representatives, Speaker Jon Burns formed the Special Committee on Resource Management that will look into Georgia's production, distribution and usage of energy.

Similarly, legislation is expected regarding the ever increasing presence of data centers, solar pro-

jects and whether the Georgia Public Service Commission should begin regulating water.

The main order of business in any session of the General Assembly is the state budget. The Public Service Commission worked with the Governor's Office of Planning and Budget and is in the process of working with the House and Senate on PSC appropriations.



STATE OF THE STATE

PSC ADOPTS NEW DATA CENTER RULE

The Public Service Commission voted unanimously to approve a new rule that allows Georgia Power to charge new data centers in a manner that will protect ratepayers.

The rule derived from the Commission's decision on the 2023 interim Integrated Resource Plan that added capacity to the grid.



The rule states that

new customers using more than 100 megawatts can be billed using terms and conditions beyond those for standard customers to address risks from these large-load users. In addition to site specific costs, the data centers would pay for costs incurred by upstream generation, transmission and distribution to data centers as construction of the centers progresses. This protects Georgia Power's residential and other commercial/industrial customers.

The new rule also allows for longer contract lengths and minimum billing requirements. This helps ensure any new high-usage customers do not leave the state before paying for new infrastructure built to handle their needs.

The rule also states that any new Georgia Power contract with a company that fits the 100 MW usage category must be submitted to the PSC for review.

Further action on data centers could occur in the 2025 IRP and in subsequent rate cases.

PRIDEMORE AT TECH SUMMIT IN D.C.

Pridemore recently spoke at the U.S. Energy Association's Energy Tech Conference in Washington DC sharing the work Georgia has done in integrated resource planning and the role of State Commissioners as the

U.S. plans for increased demand in the energy sector.

Commissioner Pridemore called for customer and system protection measures



that will allow for energy systems – electric and gas – to grow to meet this new demand. The growth is occurring with and without proper system planning varying by region and state. The system planning measures in Georgia and several other states will ensure reliability. Reliability, affordability and safety remain the primary responsibilities of state commissions as these energy demands are being met.

By ensuring contract legitimacy and consistent and near constant review of system capabilities as advised by North American Electric Reliability Corporation, states can grow generation and transmission assets to ensure reliability of systems and keep downward pressure on utility rates.

Through her work as NARUC President for 2025, Commissioner Pridemore is a leading voice on state commissions knowledge sharing and regulatory processes for meeting the growing demand of electric and gas utilities in the country.
