(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The March 2026 base charge is 63.94 a typical customer with a 1.30 DDDC Factor, and is \$48.06 qualifying seniors with a 1.30 DDDC Factor.
