(3) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.30 DDDC Factor is \$582.18 and is \$410.94 for qualifying senior citizens.						
The April 2026 base charge is \$46.14 a typical customer with a 1.30 DDDC Factor, and is \$30.26 qualifying seniors with a 1.30 DDDC Factor.
