Dear Provider:

In its Order dated December 10, 2010, the Georgia Public Service Commission (hereinafter referred to as "Commission") set the contribution factor to be used in determining contributions to the Georgia Universal Access Fund ("UAF", "the Fund") under O.C.G.A. § 46-5-167.

As of this writing, the contribution factor is 1.40%. However, the most up-to-date information will always be available on the Commission's website at <http://www.psc.state.ga.us/telecom/telecom.asp>.

Also, please use the attached remittance form to be used for quarterly remissions. Remissions are due 15 days after the end of each quarter (i.e., Q1 remission is due April 15, Q2 remission is due July 15, Q3 remission is due October 15, and Q4 remission is due January 15).

Companies with less than \$12,500 in revenue are not required to pay into the UAF, but are required to complete the UAF deposit report and mail it to the Commission.
